Self-Declaration Form for 8 per cent Rebate on Electricity Bill

You may be eligible to receive an 8% rebate on your electricity bill effective January 1, 2017 under the *Ontario Rebate for Electricity Consumers Act, 2016*. If your account meets any of the eligibility criteria below, please check off all boxes that apply, and sign and date the form. Once completed, please return to Ottawa River Power Corporation as per the instructions below.

If you qualify for the rebate, we will retroactively credit your account (as applicable) to consumption effective January 1, 2017 or to a maximum of two years from the date you provided us with the completed self-declaration form, if submitted after January 1, 2019.

Eligibility for the 8% rebate:

To be eligible to receive the 8% rebate on your electricity bill, you must qualify under at least ONE of the following criteria:

(Please check all that apply to your account)

- Annual demand for electricity of 50 kilowatts or less;
- Annual consumption of 250,000 kilowatt hours of electricity or less;
- You carry on a business that is a farming business for the purposes of the *Farm Registration and Farm Organizations Funding Act, 1993*, and you hold a valid registration number assigned under that Act or your obligation to file a farming business registration form was waived pursuant to an order made under subsection 22 (6) of that Act;
- Your account relates to one of the following:
 - i. a dwelling,
 - ii. a property, within the meaning of the *Condominium Act, 1998*,
 - iii. a residential complex, within the meaning of subsection 2 (1) of the *Residential Tenancies Act, 2006*, without regard to section 5 of that Act, or
 - iv. a property that includes one or more housing units and that is owned or leased by a co-operative within the meaning of the *Co-operative Corporations Act*.
